Carnegie-Mellon University, an educational institution located in Pittsburgh, Pennsylvania, is through Brian MacWhinney, as Associate Professor, Department of Psychology, College of Humanities and Social Sciences of the University, participating in a program known as the "Child Language Data Exchange System" which was established through a foundation grant. In order for the program to function properly many contributors will be asked to and will give permission for their work to be made available to members of a Data Exchange System which will be part of this program.

With a full understanding of the aforementioned, I hereby give permission to Brian MacWhinney, Director of the Center of the Child Language Data Exchange System at Carnegie-Mellon University, to make and circulate copies of the language transcripts which I describe under (1) below. These copies may be in computer-readable or printed format and may be distributed to scholars and other responsible parties. In order to protect the rights of human subjects whom I have studied and from whom I recorded the information found in the transcripts, the names of all the people mentioned in these transcripts are to be systematically replaced by pseudonyms and the Center agrees that it will hold the true names corresponding to the pseudonyms in confidence.

I warrant that there are no other restrictions that have been placed on the use of this data by any university committee and further warrant that neither I nor anyone associated with the gathering and dissemination of this information retain a US or foreign copyright restriction over the transcripts being circulated. Any further restrictions that I wish to place on the use of these data are listed under (2) below. It is my understanding that the Center will state these restrictions in full at the head of every copy of these transcripts that is distributed. I do not hold Brian MacWhinney or Carnegie-Mellon responsible for the enforcement of these further restrictions and indemnify and render harmless both Brian MacWhinney and Carnegie-Mellon University against any actions at law or in equity or in similar courts of any jurisdictions arising from violations of these restrictions.
